- Meeting called to order by Coach Morales at 1830
- Coach's report
 - Double check parents are getting correspondence via email/Canvas/Skyward
 - Updated schedule
 - Promotion of a more inclusive environment in the swim family
 - Emphasize their resilience and perseverance in these difficult times and how to make the most of it
 - Show compassion and grace in all things, including outside of swim
 - UIL and DPISD guidelines/restrictions:
 - face coverings-employees, parents, students, visitors +8 years of age
 - required screening-temperature check
 - for athletes-done at home prior to event
 - 50% capacity
 - no invitationals
 - no travel outside of 1 hour from school
 - top 4 from district to regional
 - top 1 from regional and next 8 fastest times to state
 - top 2 divers go to state
 - Arrive 15-20 minutes early for practice, weight room, meets, etc. for screening process
 - Maintain good sportsmanship-avoid high fives and fist bumps
 - Athletes must stay for the entire meet
 - Only parent or guardian can sign athlete out
 - Unexcused practice = suspended from meet
 - More than 3 tardies to practice = suspended from meet
 - Holiday practices that will be missed require prior communication to be excused
 - Locker room dismissal done by lanes to allow a small number of athletes to rotate for showers
 - Review the Code of Conduct per UIL/DPISD guidelines
 - removal from a meet includes the suspension of the next meet
 - As a student athlete, their social media expectation is high
 - Lettering standards- 1-6 at district, top 8 two years in a row, 4 year athlete
